Weekly Varroa Mite Update – Week Ending 27 April 2023

The detection of Varroa *destructor* in Newcastle on the 22<sup>nd</sup> June 2022 has created much anxiety within the Australian beekeeping industry. In an effort to streamline our communications to our members the QBA will now offer weekly updates to our members and affiliate clubs giving insight into our current areas of focus.

## Biosecurity Queensland and QBA weekly update 27 April 2023

## QBA Weekly update 28 April 2023

- An Autumn hive check campaign is underway to encourage the beekeeping community to undertake and report checks for varroa mites.
- Queensland beekeepers are asked to report all hive checks, even if they do not find any suspect mites, using the online <u>Bee 123 form</u> or calling the Customer Service Centre on 13 25 23.
- The number of hives you should check depends on the number of hives you keep per apiary site. If your apiary site has:
  - o between 1 and 100 hives alcohol wash test up to 48 hives
  - o between 101 and 250 hives alcohol wash test 55 hives
  - o more than 251 alcohol wash test 62 hives.
- The goal is to reach 15,000 hive checks by the end of May 2023 to help show Queensland is free from varroa mite.
- Plant Health Australia has also launched the Bee Pest Blitz campaign from 1<sup>st</sup> April.
  - This national month-long call-to-action campaign encourages beekeepers to conduct surveillance during the month of April. The Bee Pest Blitz website beepestblitz.com.au went live on 1 April and encourages beekeepers to conduct alcohol washes on their hives and report their findings.
  - Queensland beekeepers are encouraged to check their hives and report online using the even if they do not find any suspect mites
- As of Friday 21 April, Queensland Department of Primary Industries and Fisheries has resumed the issuance of permits for live bees travelling from the NSW General Emergency Zone (GEZ) into Queensland. The movement of queen bees from the GEZ into Queensland will also be considered from this date.
  - Since 21 April 2023 17 BIPs have been issued

#### Permit condition compliance inspections

The Varroa Mite Prevention and Preparedness Program (VMPPP) continues to manage ongoing permitting and compliance requirements for the movement of bees and related varroa mite carriers into Queensland. The VMPPP includes two dedicated Senior Biosecurity Officers whose operational duties encompass surveillance and compliance activities, as well as a dedicated Permitting Officer to oversee bee-related movement applications.

#### Communications

- Additional communication material is being prepared to encourage beekeepers to check their hives and report to Bee 123:
- DAF continues to meet with the QBA and industry partners fortnightly to discuss progress with prevention activities to support keeping Queensland free of varroa mite.

#### Bee 123 QLD Surveillance Dashboard Map 27<sup>th</sup> April 2023

The map below illustrates the current distribution of varroa mite surveillance activities reported to the Bee 123 portal. The QBA and DAF urge all beekeepers across Queensland to complete varroa mite surveillance activities immediately and report their results (including negative results) to the portal.

The blue dots represent negative surveillance results from **620** varroa mite surveillance activities reported to the Bee 123 portal since the 13<sup>th</sup> of July.
